PHYSICAL/CHEMICAL CHARACTERISTICS	Alcoholic solution of film-forming polymers, filled with propellants under pressure into aerosol packaging with spray valve
HAZARDS OF PRODUCT	<p>Extremely Flammable – risk of explosion in event of fire Do not spray on naked flame Pressurised container</p> <p>Eyes contact: Can cause irritation of the conjunctiva. Do not spray into eyes. Ingestion: Slightly toxic Skin contact: Can cause irritation if left in contact with the skin, undiluted for long periods, or sensitisation in sensitised individuals. Inhalation: Avoid intensive inhalation. Can cause irritation of the respiratory tract.</p>
FIRST AID	<p>Eyes: Rinse thoroughly with luke warm water. If irritation persists, seek medical advice. Ingestion: Do not induce vomiting. Rinse out mouth and drink about one glass of water. Seek prompt medical advice, if appropriate. Skin: Wash well with water. If irritation persists, seek medical advice. Inhalation: If intensive, remove affected person to fresh air. EMERGENCY MEASURES	<p>Aerosols – Risk of explosion in event of fire. Inform fire brigade of presence of aerosols Spillage: 1) Turn off/disconnect any possible sources of ignition. Extinguish any cigarettes. 2) Wipe up excess with cloths 3) Use hot water to wipe down floor and clean with common cleaning agent. 4) If large amounts involved, dispose of cloths by controlled incineration, risk of fire. 5) Wipe area dry.</p>

STORAGE	Store in a cool, dry place (room temperature). Protect from sunlight and temperatures above 50°C. Do not store close to naked flames or sources of heat or use in the direct vicinity of hooded dryers and infra-red lamp dryers. Keep out of reach of children.
